PLEASE NOTE

- This enrolment form will apply only to those Eligible Shares selected by you on the reverse side and registered in the name(s) indicated below.
- Requests to enrol in the Dividend Reinvestment Option or Stock Dividend Option must be received by CIBC Mellon Trust Company at least 5 business days preceding the relevant Dividend Record Date (as defined in the Plan) otherwise participation will not begin until the next following Dividend Record Date.
- The first time you participate in the Share Purchase Option payment must be made by way of personal cheque. Subsequent payments in respect of the Share Purchase Option may be made by personal cheque or money order.
- Personal cheques or money orders payable to CIBC Mellon Trust Company in respect of the Share Purchase Option must be dated and received at least 5 business days preceding the Monthly Purchase Date (as defined in the Plan) otherwise the payment will not be invested until the next Monthly Purchase Date. No interest is paid on funds held pending investment.
- If you are a registered shareholder and wish to make payments for the purchase of shares on behalf of one or more Beneficial Shareholders, you must first file a declaration in each CIBC fiscal year in which such purchases are to be made, stating that not more than \$50,000 is being invested on behalf of each Beneficial Shareholder during that year.
- If you are completing the enrolment form in a representative capacity, such as an agent, executor, administrator or trustee, you must enclose satisfactory evidence of authority to act in this capacity.
- Share certificates are only issued upon your request.
